- I. The meeting was Called to Order, Dr. Daniel Juarez at 9:00 a.m. and asked if there was a board quorum to conduct the board meeting as posted and announced. Mr. Suarez stated that with the listed board members above there was a quorum and we could proceed to conduct the board meeting following the posted agenda. Dr. Juarez then requested to proceed with the first item on the agenda.

III. Briefing Items:

A. It is official the building Refinance has been completed. – A. Suarez

Mr. Suarez stated it was official now that the organization had refinanced the two mortgage loans (CAN Industries and Vantage Bank) into one at a lower interest rate and will be paid off in sixteen years. At the new interest rate we save about \$5,000 per month and \$60,000 per year. Dr. Juarez stated that this was good news

and it seem that one day that Positive Solutions Inc./Charter School will own its facility,

Dr. Juarez then asked to proceed with the next agenda item.

IV. Resolution Items:

A. Approval of the Board Meeting Minutes held May 13, 2017 - A. Suarez

Mr. Suarez then asked the board members to turn to tab IV-A there they will find the board meeting minutes held on May 13, 2017. Dr. Juarez then requested a motion to approve the Board Meeting Minutes for the board meeting held on May 13, 2017 as presented. Dr. Vasquez then made the motion as stated by Dr. Juarez. Dr Bernal then seconded the motion and a call for questions was called. The vote was then taken to approve the Board Meeting Minutes as presented on May 13, 2017 passed unanimously. B. Review and approval of the Positive Solutions Charter School Comprehensive Needs Assessment for the 2017-2018 school year – A. Suarez

As part of the CNA review the accomplishments and short falls are put together to develop the District/Campus Improvement Plan for the coming 17-18 school year. A call for question was made. Dr. Juarez asked all in favor and the motion approving Student Bullying Policy presented passed unanimously. E. Review and approval of the Board's Student Suicide Policy – A. Suarez

Mr. Suarez requested the board members to turn tab IV-E. There the board member will find a Student Suicide Policy being required by the legislature during the last legislation. Dr. Juarez asked if this was another requirement the legislature like the Bullying Policy. Mr. Suarez stated that yes it was a bill passed this past summer. There the will find a copy of the Notice of Grant Award (NOGA) for the Ttle I Part A in the amount of \$76,901 and Title IV in the amount of \$10,000. Mr. Suarez stated that these two grants will be added to the 2017-2018 School Year Budget. Dr. Juarez asked for a motion to approve accepting and activating the Title I Part A in the amount of \$76,901 and approving and accepting the Title IV in the amount of \$10,000 as presented. Dr. Vasquez then made the motion as stated by Dr. Juarez and Dr. Bernal seconded the motion. A call for question was then called. The vote was

then taken and the motion passed unanimously. Dr. Juarez then request to proceed with the next board item.

G. Review and accept the 2017-2018 IDEA-B Grant in the amount of \$33,772 – A. Suarez

Mr. Suarez asked board member to turn to tab IV-G. There they will find a copy of the Notice of Grant Award (NOGA) for the IDEA-B Grant in the amount of \$33,772 for Special Needs Student. Mr. Suarez explained that this grant will also be added to the 2017-2018 School Year Budget. Dr. Juarez requested a motion to accept an add the IDEA-B Grant as presented. Mrs. Latour made the motion as stated by Dr. Juarez. Dr. Bernal then seconded the motion. A call for questions was made. Dr. Juarez then asked all in favor the motion to accept and activate the IDEA-B in the amount of \$33,772 and add it to the 2017-2018 School Budget. The motion passed unanimously. Dr. Juarez then asked to proceed with the next board agenda item.
